No pulmonary change was found at 1 mg/m ³ which is most relevant to potential human exposure. A minimal to mild degree of fibrosis was noted in 22% of the animals at 4 mg/m ³ , and a mild to moderate degree of fibrosis was observed in 92% of the animals at 16 mg/m ³ . These findings are attributed to "lung overloading", a generic response to excessive amounts of any dust retained in the lung for a prolonged interval.
